For the Complex task, however, the swimlane is irrelevant, and routing and assignments are typically more complicated. Note: Swimlanes are the horizontal lines that run across the process editor. All flow objects must be placed within a swimlane. Swimlanes can also be used to group flow objects based on the roles defined within your process. Swimlanes that contain user tasks must have roles assigned to them. Swimlanes visually display the role responsible for performing each flow object within your process. Additionally, you can have multiple swimlanes that are assigned to the same role. Swimlanes can make your process more readable when you must use the same role in different parts of the same process.
